Approving and accepting a grant in the in the amount of \$137,047 from the United States Department of Health and Human Services, Health Resources and Services Administration, to fund the FSM Maternal and Child Health Services Program for the budget period from October 1, 2022 to September 30, 2024, including all the terms and conditions of the assistance.

1           WHEREAS, on August 31, 2023, the United States through the  
2 Department of Health and Human Services, Health Resources and  
3 Services Administration, issued a Notice of Award in the amount of  
4 \$137,047 to fund and support the FSM Maternal and Child Health  
5 Services Program; and

6           WHEREAS, the budget period is from October 01, 2022 to  
7 September 30, 2024; and

8           WHEREAS, section 210 (2) of title 55 of the Code of the  
9 Federated States of Micronesia (Annotated), as amended, requires  
10 that for foreign financial assistance to be valid it must be  
11 approved by Congress by resolution; and


12           WHEREAS, the grant is subject to specific terms and  
13 conditions; now, therefore,


14           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
15 States of Micronesia, Third Regular Session, 2024, that Congress  
16 hereby approves are accepts the \$137,047 grant from the United  
17 States Department of Health and Human Services, including all the  
18 specific terms and conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this  
2 resolution be transmitted to the President of the Federated  
3 States of Micronesia, the Secretary of the Department Health and  
4 Social Affairs, the Secretary of the Department of Finance and  
5 Administration, and the Secretary of the Department of Justice.
