A RESOLUTION

Setting the ceiling of the total funds estimated to be available for appropriation from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2024.

1           WHEREAS, section 104 of title 55 of the Code of the Federated  
2 States of Micronesia (Annotated), as amended, requires that  
3 Congress adopt a resolution setting forth the total funds  
4 estimated to be available for appropriation from the General Fund  
5 and any special funds of the National Treasury of the Federated  
6 States of Micronesia for each fiscal year; now, therefore,

7           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
8 States of Micronesia, Third Regular Session, 2024, that the amount  
9 estimated to be available for appropriation for the fiscal year  
10 ending September 30, 2024, is set at \$79,394,766 of which  
11 \$76,782,174 is from domestic revenues, and \$1,000,000 will be  
12 available from the Amended Compact sector grant and \$1,612,592  
13 will be available from the Supplemental Education Grant; and


