A RESOLUTION

Approving and accepting a grant in the amount of \$514,127 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention (CDC) for the budget period beginning December 01, 2023 to November 30, 2024 to fund Component A – Strengthening the Public Health Infrastructure, Workforce, and Data Systems in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, on November 20, 2023, the United States through the
2 Department of Health and Human services, Centers for Disease
3 Control and Prevention (CDC), issued a Notice of Award in the
4 amount of \$514,127 for the purpose of funding Component A -
5 Strengthening and Public Health Infrastructure, Workforce, and
6 Date Systems in the FSM; and

7 WHEREAS, the budget period of this grant is from December 1,
8 2023 to November 30, 2024, to support Strategy A2 Foundational
9 Capabilities; and

10 WHEREAS, section 210 (2) of title 55 of the Code of the
11 Federated States of Micronesia (Annotated), as amended, requires
12 that for foreign financial assistance to be valid it must be
13 approved by Congress for approval; and

14 WHEREAS, the grant is subject to certain terms and
15 conditions; now, therefore,

16 BE IT RESOLVED by the Twenty-Third Congress of the Federated
17 States of Micronesia, Third Regular Session, 2024, that Congress

1 hereby approves and accepts the \$514,127 grant from the United
2 States Department of Health and Human Services, Centers for
3 Disease Control and Prevention, including all the terms and
4 conditions thereof,

5 BE IT FURTHER RESOLVED that certified copies of this
6 resolution be transmitted to the President of the Federated
7 States of Micronesia, the Secretary of the Department of Health
8 and Social Affairs, the Secretary of the Department of Finance and
9 Administration and the Secretary of the Department of Justice.
