Authorizing the President to resubmit the nomination of Mr. Myron S. Hashiguchi to serve as a member of the FSM Petroleum Corporation, representing the National Government.

1           WHEREAS, during the Second Regular Session of the Twenty-  
2 Third Congress the President submitted the nomination of Mr.  
3 Myron S. Hashiguchi to serve as a board member of the FSM  
4 Petroleum Corporation pursuant to 27 F.S.M.C. section  
5 214A(1)(a); and; and

6           WHEREAS, the resolution approving the nomination has not  
7 been adopted by Congress; and

8           WHEREAS, under section 207 of title 2 of the Code of the  
9 Federated States of Micronesia (Annotated), as amended, any  
10 nomination previously rejected may not be resubmitted by the  
11 President during the Twenty-Third Congress without authorization  
12 from Congress; now, therefore,

13           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
14 States of Micronesia, Third Regular Session, 2024, that Congress  
15 hereby authorizes the President to resubmit the nomination of  
16 Mr. Myron S. Hashiguchi to serve as a member of the FSM  
17 Petroleum Corporation, representing the National Government; and




