A RESOLUTION

Authorizing the President to resubmit the nomination of Mr. Roger Arnold to serve as a member of the National Oceanic Resource Management Authority (NORMA) Board of Directors, representing the state of Chuuk.

1 WHEREAS, during the First Special Session of the Twenty-
2 Third Congress the President submitted the nomination of Mr.
3 Roger Arnold to serve as a member of the National Oceanic
4 Resource Management Authority (NORMA) Board of Directors; and

5 WHEREAS, the resolution approving the nomination has not
6 been adopted by Congress; and

7 WHEREAS, under section 207 of title 2 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, any
9 nomination previously rejected may not be resubmitted by the
10 President during the Twenty-Third Congress without authorization
11 from Congress; now, therefore,

12 BE IT RESOLVED by the Twenty-Third Congress of the Federated
13 States of Micronesia, Third Regular Session, 2024, that Congress
14 hereby authorizes the President to resubmit the nomination of
15 Mr. Roger Arnold to serve as a member of the National Oceanic
16 Resource Management Authority (NORMA) Board of Directors,
17 representing the state of Chuuk; and

3 that Congress hereby confirms the nomination of Mr. Roger
4 Arnold to serve on the National Oceanic Resource Management

8 States of Micronesia, the Governor of each state of the Nation
9 and Mr. Roger Arnold.


