A RESOLUTION

Approving and accepting a grant in the amount of \$772,050 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to fund and accelerate the prevention and control of HIV, Viral Hepatitis, Sexually Transmitted Disease, and Tuberculosis in the Federated States of Micronesia and United States Affiliated Pacific Islands, including all the terms and conditions of the assistance.

1           WHEREAS, on December 08, 2023, the United States through the  
2 Department of Health and Human Services, Centers for Disease  
3 Control and Prevention (CDC) issued a Notice of Award in the  
4 amount of \$772,050 to fund and support the FSM prevention and  
5 control of HIV, Viral Hepatitis, Sexually Transmitted Disease and  
6 Tuberculosis; and

7           WHEREAS, the budget period for this grant is from January 01,  
8 2024 to December 31, 2024; and

9           WHEREAS, section 210 (2) of title 55 of the Code of the  
10 Federated States of Micronesia (Annotated), as amended, requires  
11 that for foreign financial assistance to be valid it must be  
12 approved by Congress through resolution; and

13           WHEREAS, the grant is subject to specific terms and  
14 conditions; now, therefore,


15           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
16 States of Micronesia, Third Regular Session, 2024, that Congress  
17 hereby approves and accepts the \$772,050 grant from the United


1 States Department of Health and Human Services, Centers for  
2 Disease Control and Prevention, including all the terms and  
3 conditions thereof; and

4 BE IT FURTHER RESOLVED that certified copies of this  
5 resolution be transmitted to the President of the Federated States  
6 of Micronesia, the Secretary of the Department of Health and  
7 Social Affairs and the Secretary of the Department of Finance and  
8 Administration and the Secretary of the Department of Justice.
