A RESOLUTION

Approving and accepting a grant from the United States Department of Health and Human Services, Maternal and Child Health Bureau, in the amount of \$1,335,000 to fund and support the FSM Department of Health and Social Affairs' Pediatric Mental Health Care Access programs and projects, for the budget period from September 30, 2023 to September 29, 2026, including all the terms and conditions of the assistance.

1           WHEREAS, on May 24, 2023, the United States Department of  
2 Health and Human Services, Maternal and Child Health Bureau,  
3 issued a Notice of Award to the government of the Federated States  
4 of Micronesia in the amount of \$1,335,000; and

5           WHEREAS, the purpose of the grant is to fund and support the  
6 FSM Department of Health and Social Affairs' Pediatric Mental  
7 Health Care Access programs and projects; and

8           WHEREAS, the grant will fund the remaining three years of a  
9 four-year project to support pediatric mental health care access  
10 for the budget period from September 30, 2023 to September 29,  
11 2026; and

12           WHEREAS, section 210(2) of title 55 of the Code of the  
13 Federated States of Micronesia (Annotated), as amended by Public  
14 Law No. 19-149, requires that for foreign financial assistance to  
15 be valid it must be approved by Congress by resolution; and

16           WHEREAS, the grant is subject to certain terms and  
17 conditions; now, therefore,

18           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
19 States of Micronesia, First Special Session, 2023, that Congress

1 hereby approves and accepts the grant in the amount of \$1,335,000  
2 from the United States Department of Health and Human Services to  
3 fund and support pediatric mental health care access in the  
4 Federated States of Micronesia, including all the terms and  
5 conditions thereof; and

6 BE IT FURTHER RESOLVED that certified copies of this  
7 resolution be transmitted to the President of the Federated States  
8 of Micronesia, the Secretary of the Department of Health and  
9 Social Affairs, and the Secretary of the Department of Finance and  
10 Administration.


