11 possesses the essential qualifications that make her suitable  
12 candidate to serve as the Deputy Permanent Representative of the  
13 Federated States of Micronesia to the United Nations; now,

15           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
16 States of Micronesia, First Special Session, 2023, that Congress  
17 hereby confirms the nomination of Mrs. Universe Yamase Lawrence to  
18 serve as the Deputy Permanent Representative of the Federated  
19 States of Micronesia to the United Nations in New York; and

1 BE IT FURTHER RESOLVED that certified copies of this  
2 resolution be transmitted to the President of the Federated States  
3 of Micronesia, the Governor of each state of the Nation and Mrs.  
4 Universe Yamase Lawrence.


