16 equipped with the essential qualifications that render him
17 suitable once again to serve as the Secretary of Foreign

3 that Congress hereby confirms the nomination of Mr. Lorin S.
4 Robert to serve as the Secretary of the Department of Foreign

8 States of Micronesia, the Governor of each state of the Nation,


