10 of Transportation, Communications and Infrastructure and in
11 important positions in the National Government of the Federated
12 States of Micronesia, including the Ambassador to the People's
13 Republic of China, Mr. Apis possesses the essential qualifications
14 to serve as the Secretary of the Department of Transportation,
15 Communications and Infrastructure of the Federated States of
16 Micronesia; now, therefore,

17 BE IT RESOLVED by the Twenty-Third Congress of the
18 Federated States of Micronesia, Second Regular Session, 2023, that
19 Congress hereby confirms the nomination of Mr. Carlson D. Apis to
20 serve as the Secretary of the Department of Transportation,

1 Communications and Infrastructure of the Federated States of
2 Micronesia; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated
5 States of Micronesia, the Governor of each state of the Nation
6 and Mr. Carlson D. Apis.
