A RESOLUTION

To approve and accept a grant in the amount of \$250,000 from the United States Department of Health and Human Services, Administration for Children and Families, to provide funding for the FSM Personal Responsibility Education Program (PREP), including all the terms and conditions of the assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services issued a Grant Award on December 9, 2022, to the

7 assistance that requires for its validity the approval by Congress

12 Department of Health and Human Services, Administration for


