A RESOLUTION

To approve and accept a grant in the amount of \$319,099 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, to provide funding for the FSM Community Mental Health Services Block Grant 2023, including all the terms and conditions of the assistance.

1           WHEREAS, the United States Department of Health and Human  
2 Services, Substance Abuse and Mental Health Services  
3 Administration, issued a Grant Award on February 02, 2023, to the  
4 Government of the Federated States of Micronesia providing funding  
5 in the amount of \$319,099 for the purpose of providing support for  
6 the FSM Community Mental Health Services Block Grant from October  
7 01, 2022 to September 30, 2024; and

8           WHEREAS, section 210(2) title 55 of the Code of the Federated  
9 States of Micronesia (Annotated), as amended, provides that for  
10 foreign financial assistance to be valid it must be approved by  
11 Congress by resolution; now, therefore,

12           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
13 States of Micronesia, Second Regular Session, 2023, that Congress  
14 hereby approves and accepts the \$319,099 grant from the United  
15 States Department of Health and Human Services, Substance Abuse  
16 and Mental Health Services Administration, to support the FSM  
17 Community Mental Health Services Block Grant 2023, including all  
18 the terms and conditions thereof;


