To approve and accept a grant in the amount of \$506,585 from the United States Department of Interior, National Park Service, to provide funding for the FSM National and State Historic Preservation Offices (HPOs), including all the terms and conditions of the assistance.

- 11 States of Micronesia, Second Regular Session, 2023, that Congress
- 12 hereby approved and accepts the \$506,585 grant from United States
- 13 of Department of Interior, National Park Service, to support the
- 14 FSM National and State Historic Preservation Offices, including
- 15 all the terms and conditions thereof; and
