A RESOLUTION

To approve and accept a grant in the amount of \$506,585 from the United States Department of Interior, National Park Service, to provide funding for the FSM National and State Historic Preservation Offices (HPOs), including all the terms and conditions of the assistance.

1 WHEREAS, the United States Department of Interior issued a
2 Grant Award on July 13, 2023, to the Government of the Federated
3 States of Micronesia providing funding in the amount of \$506,585
4 for the purpose of proving support to the FSM National and State
5 Historic Preservation Offices; and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, provides
8 that for foreign financial assistance to be valid it must be
9 approved by Congress by resolution; now, therefore,

10 BE IT RESOLVED by the Twenty-Third Congress of the Federated
11 States of Micronesia, Second Regular Session, 2023, that Congress
12 hereby approved and accepts the \$506,585 grant from United States
13 of Department of Interior, National Park Service, to support the
14 FSM National and State Historic Preservation Offices, including
15 all the terms and conditions thereof; and


