A RESOLUTION

APPROVING AND ACCEPTING A GRANT IN THE AMOUNT OF \$580,987 FROM THE UNITED STATES DEPARTMENT OF HEALTH AND HUMAN SERVICES, SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION, CENTER FOR SUBSTANCE ABUSE TREATMENT, TO PROVIDE FUNDING TO THE FSM DEPARTMENT OF HEALTH AND SOCIAL AFFAIRS TO IMPLEMENT THE SUBSTANCE ABUSE PREVENTION AND TREATMENT BLOCK GRANT AND ITS RELATED ACTIVITIES AND SERVICES, INCLUDING ALL THE TERMS AND CONDITIONS OF THE ASSISTANCE.

A RESOLUTION

Approving and accepting a grant in the amount of \$580,987 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment, to provide funding to the FSM Department of Health and Social Affairs to implement the Substance Abuse Prevention and Treatment Block Grant and its related activities and services, including all the terms and conditions of the assistance.

1 WHEREAS, on June 14, 2023, the United States Department of
2 Health and Human Services, Substance Abuse and Mental Services
3 Administration, Center for Substance Abuse Treatment, issued a
4 Notice of Award in the amount \$193,663 to fund the FSM Department
5 of Health and Social Affairs Substance Abuse Prevention and
6 Treatment Block Grant; and

7 WHEREAS, on August 02, 2023 the United States of Department
8 of Health and Human Services, Substance Abuse and Mental Health
9 Services Administration, Center for Substance Abuse Treatment,
10 issued a Notice of Award in the amount of \$387,324 to fund the FSM
11 Department of Health and Social Affairs Substance Abuse Treatment
12 Block Grant; and

13 WHEREAS, the purpose of these grants are to provide and
14 funding for substance abuse, prevention, and treatment services to
15 the people of the FSM with substance abuse related problems; and

16 WHEREAS, section 210(2) of title 55 of the Code of the
17 Federated States of Micronesia (Annotated), as amended, provides

1 that for foreign financial assistance to be valid it must be
2 approved by Congress by resolution; now, therefore,


3 BE IT RESOLVED by the Twenty-Third Congress of the Federated
4 States of Micronesia, Second Regular Session, 2023, that Congress
5 hereby approves and accepts the \$580,987 grant from the United
6 States Department of Health and Human Services, Substance Abuse
7 and Mental Health Services Administration, Center for Substance
8 Abuse Treatment, to provide funding support to the FSM Department
9 of Health and Social Affairs Substance Abuse and Prevention Block
10 Grant, for prevention and treatment services related to substance
11 abuse, including all the terms and conditions thereof; and

12 BE IT FURTHER RESOLVED that certified copies of this
13 resolution be transmitted to the President of the Federated States
14 of Micronesia, the Secretary of the Department of Health and
15 Social Affairs, the Secretary of the Department of Justice, the
16 Secretary of the Department of Foreign Affairs, and the United
17 States Embassy in Kolonia.


