A RESOLUTION

Approving and accepting a grant in the amount of \$250,000 from the United States Department of Education, to fund and support the FSM Department of Education, Division of Special Services, including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of
2 Education issued a Notice of Award on August 31, 2023, to the FSM
3 Department of Education, Division of Special Services for its
4 third-year grant portion of a five year project as authorized
5 under the United States Individuals with Disabilities Act
6 Amendments of 1997 in the amount of \$250,000 for the budget period
7 from August 01, 2023, to July 31, 2024; and

8 WHEREAS, the purpose of the grant assistance is to fund and
9 support the implementation and improvement of services of the FSM
10 Department of Education, Division of Special Services, towards
11 eligible children with disabilities and their families in the FSM;

13 WHEREAS, section 210 (2) of title 55 of the Code of the
14 Federated States of Micronesia (Annotated), as amended, requires
15 that for foreign financial assistance to be valid it must be
16 approved by Congress by resolution; now, therefore,

17 BE IT RESOLVED by the Twenty-Third Congress of the Federated
18 States of Micronesia, Second Regular Session, 2023, that Congress
19 hereby approves and accepts the \$250,000 grant from the United

1 States Department of Education, to fund the FSM Division of
2 Special Services and its activities, including all the terms and
3 conditions thereof; and


4 BE IT FURTHER RESOLVED that certified copies of this
