A RESOLUTION

Approving and accepting a grant in the amount of \$289,591 by the United States Department of Health and Human Services, through the Assistant Secretary for Preparedness and Response, for the budget period beginning July 01, 2023 to June 30, 2024, to fund the FSM National Bioterrorism Hospital Preparedness Program, including all the terms and conditions of the grant.

1 WHEREAS, on June 29, 2023, the United States Department of
2 Health and Human Services, through the Assistant Secretary for
3 Preparedness and Response, issued a Notice of Award in the amount
4 of \$289,591 to provide funding support to the FSM Program
5 entitled: "National Bioterrorism Hospital Preparedness Program";
6 and

7 WHEREAS, the grant will fund and support the continuation of
8 the FSM Public Health and Hospital Emergency Preparedness Program
9 in its continued effort and work program; and

10 WHEREAS, the budget period for this grant is from July 01,
11 2023 to June 30, 2024; and

12 WHEREAS, section 210((2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, requires
14 that foreign financial assistance to be valid must be approved by
15 Congress by resolution; now, therefore,

16 BE IT RESOLVED by the Twenty-Third Congress of the Federated
17 States of Micronesia, Second Regular Session, 2023, that Congress
18 hereby approves and accept the \$289,591 grant from the United

1 States Department of Health and Human Services, including all the
2 terms and condition thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated
5 States of Micronesia, the Secretary of the Department of Health
6 and Social Affairs, the Secretary of the Department of Finance
7 and Administration.


