A RESOLUTION

Approving and accepting a grant in the amount of \$478,510 by the United States Department of Health and Human Services, Centers for Disease Control and Prevention (CDC), for the budget period beginning July 01, 2023 to June 30, 2024 to fund the FSM Public Health and Hospital Emergency Preparedness Program, including all the terms and conditions of the grant.

1 WHEREAS, on June 16, 2023, the United States Department of
2 Health and Human Services, Centers for Disease Control and
3 Prevention, issued a Notice of Award in the amount of \$478,510 to
4 provide funding support to the FSM Program entitled: "FSM Public
5 Health and Hospital Emergency Preparedness Program"; and

6 WHEREAS, the grant will fund and support the continuation of
7 the FSM Public Health and Hospital Emergency Preparedness Program
8 in its continued effort and work program; and

9 WHEREAS, the budget period for this grant is from July 01,
10 2023 to June 30, 2024; and

11 WHEREAS, section 210((2) of title 55 of the Code of the
12 Federated States of Micronesia (Annotated), as amended, requires
13 that foreign financial assistance must be submitted to Congress
14 for approval; now, therefore,

15 BE IT RESOLVED by the Twenty-Third Congress of the Federated
16 States of Micronesia, Second Regular Session, 2023, that Congress
17 hereby approves and accepts the \$478,510 grant from the United
18 States Department of Health and Human Service, Centers for Disease

1 Control and Prevention, to support the FSM Public Health and
2 Hospital Emergency Preparedness Program, including all the terms
3 and conditions thereof; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 resolution be transmitted to the President of the Federated
6 States of Micronesia, the Secretary of the Department of Health
7 and Social Affairs and the Secretary of the Department of Finance
8 and Administration.


