A RESOLUTION

Authorizing the President to resubmit the nomination of Mr. Leonito M. Bacalando Jr., to serve as the Secretary of the Department of Justice of the Federated States of Micronesia.

1 WHEREAS, during the First Special Session of the Twenty-
2 Third Congress the President submitted the nomination of Mr.
3 Leonito M. Bacalando Jr. to serve as the Secretary of the
4 Department of Justice of the Federated States of Micronesia; and

5 WHEREAS, the resolution approving the nomination has not
6 been adopted by Congress; and

7 WHEREAS, under section 207 of title 2 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, any
9 nomination not acted upon within two consecutive sessions of
10 Congress may not be resubmitted by the President during the
11 Twenty-Third Congress without authorization from Congress; now
12 therefore,

13 BE IT RESOLVED by the Twenty-Third Congress of the Federated
14 States of Micronesia, Third Regular Session, 2024, that Congress
15 hereby authorizes the President to resubmit the nomination of
16 Mr. Leonito M. Bacalando Jr. to serve as the Secretary of the
17 Department of Justice; and


