6 adopted by Congress; and

7 WHEREAS, under section 207 of title 2 of the Code of the

8 Federated States of Micronesia (Annotated), as amended, any

9 nomination not acted upon within two consecutive sessions of

10 Congress may not be resubmitted by the President during the

11 Twenty-Third Congress without authorization from Congress; now

12 therefore,

13 BE IT RESOLVED by the Twenty-Third Congress of the Federated

14 States of Micronesia, Second Regular Session, 2023, that

15 Congress hereby authorizes the President to resubmit the

16 nomination of Mr. Innocente I. Oneisom to serve as the FSM

17 Consul General in Honolulu, Hawaii; and


