1 WHEREAS, during the Second Regular Session of the
2 Twenty-Third Congress the President submitted the
3 nomination of Ms. Myjolyne Marie Kim to serve as the
4 Deputy Chief of Mission at the FSM Embassy in Tokyo, Japan
5 and

6 WHEREAS, the resolution approving the nomination has
7 not been adopted by Congress; and

8 WHEREAS, under section 207 of title 2 of the Code of
9 the Federated States of Micronesia (Annotated), as amended,
10 any nomination previously rejected may not be resubmitted
11 by the President during the Twenty-Third Congress without
12 authorization from Congress; now therefore,

13 BE IT RESOLVED by the Twenty-Third Congress of the
14 Federated States of Micronesia, Second Regular Session,
15 2023, that Congress hereby authorizes the President to
16 resubmit the nomination of Ms. Myjolyne Marie Kim to serve
17 as the Deputy Chief of Mission at the FSM Embassy in Tokyo,
18 Japan; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia and Ms. Myjoylynn Marie Kim.


