1 WHEREAS, during the Second Regular Session of the Twenty-
2 Third Congress the President submitted the nomination of Mr.
3 Hentrick V. Eveluck to serve as the FSM Consul General in Guam,
4 USA; and

5 WHEREAS, the resolution approving the nomination has not been
6 adopted by Congress; and

7 WHEREAS, under section 207 of title 2 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, any
9 nomination previously rejected may not be resubmitted by the
10 President during the Twenty-Third Congress without authorization
11 from Congress; now therefore,

12 BE IT RESOLVED by the Twenty-Third Congress of the Federated
13 States of Micronesia, Second Regular Session, 2023, that
14 Congress hereby authorizes the President to resubmit the
15 nomination of Mr. Hentrick V. Eveluck to serve as the FSM Consul
16 General in Guam, U.S.A; and


