Approving and accepting a grant from the United States of Department of Transportation, to fund the Airport Improvement Project (AIP) for the state of Kosrae, in the amount of \$314,716, including all the terms and conditions of the assistance.

1 WHEREAS, on May 23, 2023, the United States Department of
2 Transportation issue a Grant Award to the Government of the
3 Federated States of Micronesia in the amount of \$314,716 for a
4 project in Kosrae entitled: "Improve Airfield Lighting Vault
5 Project"; and

6 WHEREAS, the grant was accepted by the Secretary of the
7 Department of Transportation Communications and Infrastructure on
8 behalf of the Federated States of Micronesia; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, requires
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; now, therefore,

15 hereby approves and accepts the \$314,716 grant from the United
16 States Department of Transportation, including all the terms and
