Authorizing the President to resubmit the nomination of Mr. Etop Y. Malon to serve as the National Election Commissioner for the state of Chuuk.

1 WHEREAS, during the Second Regular Session of the Twenty
2 Third Congress the President submitted the nomination of Mr. Etop
3 Y. Malon to serve as the National Election Commissioner for the
4 state of Chuuk; and

5 WHEREAS, the resolution approving the nomination was
6 previously rejected by Congress;

7 WHEREAS, under section 207 of title 2 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, any
9 nomination previously rejected may not be resubmitted by the
10 President during the Twenty-Third Congress without authorization
11 from Congress; now, therefore,

12 BE IT RESOLVED by the Twenty-Third Congress of the Federated
13 States of Micronesia, Second Regular Session, 2023, that Congress
14 hereby authorizes the President to resubmit the nomination of Mr.
15 Etop Y. Malon to serve as the National Election Commissioner for
16 the state of Chuuk; and


