A RESOLUTION

To amend Rule 7, Section 1(b) of the Official Rules of Procedure of the Twenty-Third Congress of the Federated States of Micronesia to update the list of departments and offices falling within the jurisdiction of the Ways and Means Committee.

1 WHEREAS, the Congress of the Federated States of 2 Micronesia is governed by its Official Rules of Procedure; and 3 WHEREAS, Section 1(b) of Rule 7 of the Official Rules 4 of Procedure of the Twenty-Third Congress of the 5 Federated States of Micronesia provides a non-exhaustive 6 list of subjects that fall within the jurisdiction of the 7 Committee on Ways and Means when reviewing the budget of 8 the President; and 9 WHEREAS, a Congressional Resolution is an acceptable 10 mechanism for amending the Official Rules of Procedure of 11 Congress under Rule 15 of the Official Rules of Procedure; now, 12 therefore, 13 BE IT RESOLVED by the Twenty-Third Congress of the 14 Federated States of Micronesia, First Special Session, 2023, 15 that Rule 7, Section 1(b) of the Official Rules of Procedure of 16 the Twenty-Third Congress of the Federated States of Micronesia is hereby amended to read as follows: 17

18 "Section 1. Ways and Means.

19 (a) The Committee on Ways and Means shall consist

of not more than seven members with at least one 1 2 member from each of the four States. It shall be 3 the duty of this committee to consider and report on 4 all bills, resolutions, and other matters referred 5 to it pertaining to the finances and financial administration of the Government of the Federated 6 7 States of Micronesia or any of the four constituent 8 States or a municipality thereof, such subjects to include but not be limited to taxes, export duties, 9 10 and tariffs; non-tax revenues; budgets; 11 expenditures; appropriation measures; loans, borrowing, or indebtedness on public credit; 12 13 monetary claims, funding arrangements, or 14 requirements; accounting and audits, past, present 15 or proposed; the issuance and regulation of 16 currency; and other related subjects, including 17 Presidential nominations submitted to the Speaker 18 which require the advice and consent of Congress. 19 Bills and resolutions or other matters pertaining to 20 internal organization or management of the Congress of the Federated States of Micronesia shall also 21 22 fall within the scope of the duties of the Congress. 23 It shall be the duty of this committee to consider, investigate, and recommend to the Congress any 24 25 needed revisions of existing laws or new legislation

1	relating to any subject matter within its
2	jurisdiction.
3	(b) This committee shall be responsible for
4	reviewing specific subjects in the budget of the
5	President, and all supplementals thereto, which make
6	a request for an appropriation, which relates to a
7	subject matter within its jurisdiction. Pursuant to
8	its review the committee shall recommend whether the
9	matters referred to it, or portions thereof, will be
10	authorized, and if so, in what amount. Following
11	its review the committee shall promptly report its
12	recommendation to the Congress. Those subjects
13	which fall within the jurisdiction of this committee
14	include, but are not limited to, the following:
15	(i) Department of Finance and
16	Administration;
17	(ii) Office of the President;
18	(iii) [Office of Statistics, Budget,
19	Overseas Development Assistance and
20	Compact Management; and] Office of
21	Personnel;
22	(iv) Public Auditor;
23	(c) This committee shall be responsible for
24	reviewing all reports referred to it by the Congress
25	from other standing committees as pertain to the

budget of the President and all supplementals 1 2 Pursuant to said review this committee thereto. 3 shall determine to what extent funds are available 4 to meet the recommendations of the committee, which 5 authored the referred report. After this determination has been made, this committee shall 6 7 promptly report its recommendation to the Congress. 8 In no instance may this committee recommend an 9 appropriation in an amount higher than that 10 recommended by the Committee which authored the 11 referred report. However, this committee may 12 recommend an appropriation in a lower amount if 13 funds are determined to be insufficient to meet the 14 recommendations contained in the referred report."
