12          the United Nations since 2003 and as Permanent Representative  
13          since 2022, and previously in various official capacities in the  
14          Department of Foreign Affairs, Mr. Lippwe possesses the essential  
15          qualifications that make him a suitable candidate to continue  
16          serving as the Permanent Representative of the Federated States of  
17          Micronesia to the United Nations; now, therefore,
