6 consent of Congress pursuant to section 2(d), Article X, of the
7 Constitution of the Federated States of Micronesia, and 2 F.S.M.C.
8 §207; and

9 WHEREAS, Mr. Cantero is an experienced diplomat having
10 served the Department of Foreign Affairs of this Nation for many
11 years; and

12 WHEREAS, he served as the Deputy Secretary of the
13 Department of the Foreign Affairs, and had served as the Assistant
14 Secretary of the Department of the Foreign Affairs heading the
15 Division of Americas and European Affairs; now, therefore,

16 BE IT RESOLVED by the Twenty-third Congress of the
17 Federated States of Micronesia, First Special Session, 2023, that
18 the Congress hereby confirms the nomination of Mr. Ricky F.
19 Cantero to serve as the Deputy Secretary of the Department of
20 Foreign Affairs of the Federated States of Micronesia; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Governor of each state of the Nation, and Mr.
4 Ricky F. Cantero.


