1 WHEREAS, during the First Special Session of the Twenty-Third
2 Congress the President submitted the nomination of Mr. Etop Y.
3 Malon to serve as the National Election Commissioner of the state
4 of Chuuk; and

5 WHEREAS, the resolution approving the nomination has not been
6 adopted; and

7 WHEREAS, under 2 F.S.M.C. section 207, the nomination may not
8 be resubmitted by the President during the Twenty-Third Congress
9 without authorization from Congress; now, therefore,

10 BE IT RESOLVED by the Twenty-Third Congress of the Federated
11 States of Micronesia, First Special Session, 2023, that Congress
12 hereby authorizes the President to resubmit the nomination of Mr.
13 Etop Y. Malon to serve as the National Election Commissioner for


