A RESOLUTION

To approve and accept a grant in the amount of \$135,536 from the United States Department of Health and Human Services, Health Resources and Services Administration, to provide funding for the FSM Maternal and Child Health Services, including terms and conditions of the assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services, Health Resources and Services Administration issued a
3 Grant Award on April 07, 2023, to the Government of the
4 Federated States of Micronesia to providing funding in the
5 amount of \$135,536 for the purpose of providing support to the
6 FSM Maternal and Child Health Services; and

7 WHEREAS, this grant is considered a foreign financial
8 assistance that requires for its validity the approval by
9 Congress through resolution; now, therefore,

10 BE IT RESOLVED by the Twenty-Third Congress of the
11 Federated States of Micronesia, Second Regular Session, 2023,
12 that Congress hereby approve and accepts the \$135,536 grant from
13 United States Department of Health and Human Services, Health
14 Resources and Services Administration, to fund the FSM Maternal
15 and Child Health Services, including all the terms and


