A RESOLUTION

To approve and accept a grant in the amount of \$1,558,494 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to provide funding for the FSM Immunization Program, including terms and conditions of the assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services, Centers for Disease Control and Prevention, issued a
3 Grant Award on July 12, 2023, to the Government of the Federated
4 States of Micronesia to providing funding in the amount of
5 \$1,558,494 for the purpose of providing support to the FSM
6 Immunization Program; and

7 WHEREAS, this grant is considered a foreign financial
8 assistance that requires for its validity the approval by
9 Congress through resolution; now, therefore,

10 BE IT RESOLVED by the Twenty-Third Congress of the
11 Federated States of Micronesia, Second Regular Session, 2023,
12 that Congress hereby approve and accepts the \$1,558,494 grant
13 from United States Department of Health and Human Services,
14 Centers for Disease Control and Prevention, to fund the FSM
15 Immunization Program, in including all the terms and conditions


