The Speaker of the Congress of the Federated States of Micronesia shall have the authority to reallot funds appropriated by one subsection within a section to another subsection within the same section; PROVIDED, HOWEVER, that not more than 10 percent of the funds appropriated by a section of this act shall be reallotted to another section of this act; PROVIDED FURTHER, HOWEVER, that no funds shall be realloted to recruit unbudgeted personnel. The 10 authority to obligate funds appropriated by this act shall lapse as of September 30, 1982. 12 Section 5. Effective date.
