A BILL FOR AN ACT

Section 2. All funds appropriated by this act shall be allotted, managed,		
administered, and accounted for in accordance with applicable law, including,		
but not limited to, the Financial Management Act of 1979. The allottee shall		
be responsible for ensuring that these funds, or so much thereof as may be		
necessary, are used solely for the purpose specified in this act, and that		
no obligations are incurred in excess of the sum appropriated. The authority		
of the allottee to obligate funds appropriated by this act shall lapse as		
of September 30, 1982.		
Section 3. This act shall become law upon approval by the President of		
the Federated States of Micronesia or upon its becoming law without such		
approval.
