#### A BILL FOR AN ACT

To amend sections 1 through 7 of Public Law No. 2-21 to appropriate the sum of \$4,100,175 from the General Fund of the Federated States of Micronesia and the sum of \$4,278,000 from the United States Grant Special Fund for the fiscal year ending September 30, 1982, for the operations of the executive branch, legislative branch, National judiciary, public auditor, agencies of the National Government, and for special programs, contributions, grants, subsidies, and refunds of the National Government during fiscal year 1982; to establish employment ceilings; and for other purposes.

7 Bank The number of positions authorized applies individually 2 to each of the Departments and offices of the executive branch, 3 legislative and judiciary branches, and to the agencies as provided above, except that the President may transfer up to 12 positions 5 between Departments and offices of the executive branch. This 6 7 authorization of positions covers all permanent employees and all contract personnel whose employment extends for one year or more 9 (including positions funded from Federal programs). No funds may be expended for unbudgeted positions." 10 Section 2.
