A BILL FOR AN ACT

To amend Public Law No. 1-146 appropriating the sum of \$415,900 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1981, for the purpose of funding certain public projects in the State of Ponape, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 1 of Public Law No. 1-146 is hereby amended to read as follows: 2 3 "Section 1. The sum of \$415,900 or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal 5 year ending September 30, 1981, for the purpose of 6 funding certain public projects in the State of Ponape.
