A BILL FOR AN ACT

To amend Public Law No. 1-146 appropriating the sum of \$415,900 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1981, for the purpose of funding certain public projects in the State of Ponape, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 1-146 is hereby amended to read as follows:

"Section 1. The sum of \$415,900 or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1981, for the purpose of funding certain public projects in the State of Ponape. The sum appropriated shall be apportioned in the following manner:

(1) Construction of Ponape circumferential road.....\$ 148,900

(2) Construction of farm roads, small bridges, water systems, channels, or small-scale hydro-electric plants, or repair of classrooms, or public facilities or acquisition of equipment.

(b) Kitti..... 25,000

(3) Airstrip projects, school facility renovation, dispensary renovation.

- 15 Section 2. Section 2 of Public Law No. 1-146 is hereby amended
- 16 to read as follows:
- 17 "Section 2. All funds appropriated by this act shall
- 18 be allotted, managed, administered, and accounted for in
- 19 accordance with applicable law, including, but not limited
- 20 to, the Financial Management Act of 1979. The allottee
- 21 shall be responsible for ensuring that these funds, or
- 22 so much thereof as may be necessary, are used solely for
- 23 the purpose specified in this act, and that no obligations
- 24 are incurred in excess of the sum appropriated. The author-
- 25 ity of the allottee to obligate funds appropriated by this

1 act shall lapse as of September 30, 1982/ 1983."

2 Section 3. This act shall become law upon approval by the  
3 President of the Federated States of Micronesia or upon its  
4 becoming law without such approval.
