A BILL FOR AN ACT

To amend section 101 of title 3 of the Code of the Federated States of . Micronesia to reapportion the Congress in 1984, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA

| 1 | Section 1. Section 101 of title 3 of the Code of the Federated |
| 2 | States of Micronesia is hereby amended to read as follows: |
| 3 | "Section 101. Membership and terms of office. The Congress |
| 4 | of the Federated States of Micronesia shall be a unicameral |
| 5 | National legislature consisting of fourteen Members to be |
| 6 | known as Senators as follows: |
| 7 | (1) four at-large Members, one from each of the States |
| 8 | of Kosrae, Ponape, Truk, and Yap, who are elected on the |
| 9 | basis of State equality to serve for a four-year term. |
| 10 | (2) ten Members serving for a term of two years and |
| 11 | elected on the basis of population as follows: |
| 12 | (a) one Member elected from Kosrae as a single- |
| 13 | member congressional district; |
| 14 | (b) one Member elected from Yap as a single- |
| 15 | member congressional district; |
| 16 | (c) three Members elected from Ponape, one of |
| 17 | whom representing each single-member congressional district |
| 18 | (d) five Members elected from Truk one of whom |
| 19 | representing each single-member congressional district. |
| 20 | (3) single-member congressional districts shall be |
| 21 | reapportioned at least every 10 years. The first such |
| 22 | reapportionment shall be made in 1959 1984 with 15 Members |
| 23 | serving for a term of two years and elected on the basis of |
| 24 | population as follows: |

(a) one Member elected from Kosrae as a single-

| 8 | representing each single-member congressional district. |
| 9 | (4) Each Senator elected at large shall hold office |
| 10 | for a term of four years. Senators elected on the basis of |
| 11 | population shall each hold office for a term of two years. |
| 12 | The terms of office of all Members of the Congress of the |
| 13 | Federated States of Micronesia shall commence at noon |
| 14 | on the tenth day of May following their election, except |
| 15 | as otherwise provided by law. Any Member elected or appointed |
| 16 | to fill a vacancy shall serve only for the unexpired term |
| 17 | of the person he succeeds." |
| 18 | Section 2. This act shall become law upon approval by the President |
| 19 | of the Federated States of Micronesia or upon its becoming law without |
| 20 | such approval. |
