To establish the Federated States of Micronesia Social Security System, to provide for devolution from the Trust Territory Social Security System, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 CHAPTER 1.

2 GENERAL PROVISIONS

- 3 Section 101. Short title. This act is known and may be cited as
- 4 the "Federated States of Micronesia Social Security Act."
- 5 Section 102. Declaration of policy. The purpose of this act is to
- effect economy and efficiency in the fields of government and business
- by providing a means whereby employees may be ensured a measure of
- security in their old age and given an opportunity for leisure without
- hardship and complete loss of income. Further, to provide survivors'
- 10 insurance for wage earners and their dependents.
- 11 Section 103. Definitions. In this act, unless the context
- otherwise requires, the following definitions shall be applicable: 12
- 13 (1) "Became disabled" means the first month in which an
- individual is under a disability and is both fully and currently 14
- 15 insured.
- "Board " means the Federated States of Micronesia Social 16 (2)
- Security Board provided for by section 201 of this act 17
- 18 "Child or spouse" means that an applicant is the child or
- 19 spouse of an individual if the court of the state in which the
- 20 individual was domiciled at the time of his death has or would find the
- 21 applicant to be the individual's child or spouse in determining the
- 22 devolution of intestate personal property.
- 23 (4) "Contributions" means the tax imposed upon income of
- covered employees and the tax imposed upon employers on account of wages 24
- 25 paid to a covered employee.

1	(5) "Disability" means inability to engage in any substantial
2	gainful employment by reason of any medically determinable physical or
3	mental impairment which can be expected to result in death or which has
4	lasted or can be expected to last for a continuous period of not less
5	than 12 months.
6	(6) "Earning test" means that an individual who receives a
7	retirement, disability or survivor benefit and who works in covered or
8	noncovered employment shall have his quarterly benefit reduced by \$1 for
9	each \$2 earned in a quarter, except there shall be no reduction for the
10	first \$200 earned in a quarter. The reduction shall be applied in one
11	of the subsequent two quarters immediately after the quarter in which
12	the earnings were made, or as soon as possible thereafter.
13	(7) "Employee" means:
14	(a) Any officer of a corporation; or
15	(b) Any individual who, under the usual common law rules
16	applicable in determining the employer-employee relationship, has the
17	status of an employee; or
18	(c) Any self-employed person who has at least one
19	employee for whom he is required to report in a given quarter; or
20	(d) Any self-employed person who had more than \$10,000
21	of annual gross revenue in the preceding calendar year.
22	(8) "Employment" means any service by an employee for the
23	Federated States of Micronesia employer employing him, irrespective of
24	where such employment shall be performed, except family employment.
25	(9) "Family employment" means employment of a worker by a

- 1 member of the household, a parent or a son or daughter except that the
- 2 worker may apply to the Board for a determination that such employment
- 3 is bona fide covered employment subject to this act.
- 4 (10) Insured status can mean any of the following:
- 5 (a) "Fully insured individual" means any individual who
- 6 has not less than one quarter of coverage for each year beginning after
- 7 June 30, 1968, or for each year after attaining the age of 21, whichever
- 8 is later, and up to but excluding the year in which he attained
- 9 retirement age, became disabled, or died, whichever first occurred,
- 10 except that in no case shall an individual be a fully insured individual
- 11 unless he has at least 12 quarters of coverages.
- 12 (b) "Currently insured individual" means any individual
- 13 who has had not less than 8 quarters of coverage during the 13 quarter
- 14 period ending with:
- (i) The quarter in which he died, or
- 16 (ii) The quarter in which he became entitled to old
- 17 age insurance benefits, or
- 18 (iii) The quarter in which he became disabled,
- 19 whichever first occurs.
- 20 (11) "Quarter" and "calendar quarter" mean a period
- 21 of three calendar months ending on March 31, June 30, September 30, or
- 22 December 31. "Quarter of coverage" means a quarter in which the
- 23 individual has been paid \$50 or more in wages in employment
- 24 subject to this act.
- 25 (12) "Wages" means remuneration paid subject to the provisions

of this act, including the cash value of all remuneration paid in any

- medium other than cash and remuneration accruing to a self-employed
- person. Remuneration accruing to a self-employed person shall be deemed
- to be twice the amount paid to the highest paid employee reported by the
- self-employed person in a quarter, \$1,500 maximum per quarter.
- Remuneration one thousand accruing to a self-employed person who has no
- covered employees shall, for each quarter of a year, be deemed to be 2.5
- percent of the gross revenue of the business for the previous calendar
- year, subject to \$1,500 maximum. Remuneration paid for any service
- which is more or less than a whole dollar shall, as may be prescribed by 10
- 11 regulations, be computed to the nearest dollar. Wages shall not
- include: 12
- (a) That part of remuneration in excess of \$1,500 paid 13
- in a quarterly reporting period by one employer; 14
- (b) Any payment on account of sickness or accident 15
- disability, or medical or hospitalization expenses made by an employer 16
- to or on behalf of an employee; 17
- 18 (c) Any payment made to or on behalf of an employee or
- 19 to his beneficiary from a trust or annuity;
- 20 (d) Remuneration paid in any medium other than cash to
- an employee for service not in the course of the employer's trade or 21
- business or for domestic service in a private home of an employer; 22
- (e) Remuneration paid for casual or intermittent labor 23
- not performed in the course of the employer's trade or business when 24
- such employment does not exceed employment in more than one week in each

- 2 (f) Remuneration from family employment subject to the
- 3 provisions of this act.
- Section 104. Susceptibility of benefits, contributions, and funds
- to legal process or assignment. The benefits, the employee and employer
- contributions, and the securities in the several funds from all taxes
- 7 presently or hereinafter levied shall not be subject to execution,
- 8 attachment, or garnishment and shall be nonassignable except as
- 9 specifically provided in this act.
- Section 105. Violations; Penalties.
- 11 (1) Any person who knowingly makes any false statement or who
- 12 falsifies any report to or record of the Federated States of Micronesia
- 13 Social Security System in an attempt to defraud the system shall be
- 14 guilty of a misdemeanor and upon conviction thereof shall be imprisoned
- 15 for a period of not more than one year, or fined not more than \$2,000 or
- 16 both.
- 17 (2) Any person who willfully fails to report wages paid or
- 18 pay contributions required thereon shall be guilty of a misdemeanor and,
- 19 in addition to any other penalty prescribed by law, such a person shall
- 20 also pay penalties not in excess of 100 percent of the tax due plus
- 21 interest to the Board as it by regulation shall require.
- 22 (3) Any covered employer who fails to submit the quarterly
- 23 report and pay the social security tax within 10 days after the end of
- 24 the quarter shall be considered delinquent. The Board or its authorized
- 25 representatives shall be vested with the authority to levy a penalty of

1 not more than \$250 on delinquent employers.

- 2 Section 106. Accounts, budget, and costs of administration.
- 3 (1) At such time as the Social Security Board may prescribe,
- 4 the Social Security Administrator shall submit to the Board on forms and
- 5 in the manner prescribed by the Board a detailed estimate of the budget
- 6 for the next ensuing fiscal year for the proper conduct of the Social
- 7 Security System. The Social Security Administrator shall submit to the
- 8 board:
- 9 (a) The audited accounts of the income and expenditure
- 10 and the balance in the Social Security Retirement Fund for the last
- 11 completed fiscal year,
- 12 (b) A statement showing the estimated income and
- 13 expenditure for the fiscal year in progress, together with such
- 14 summaries, schedules, and supporting data as may be deemed necessary,
- 15 (c) A statement showing the estimated balance of the
- 16 Social Security Retirement Fund at the close of the fiscal year in
- 17 progress, and
- 18 (d) A budget showing the estimated income and
- 19 expenditure for the next ensuing fiscal year.
- 20 (2) For the next ensuing fiscal year, the estimated costs of
- 21 administration including salaries and wages, purchase of office
- 22 supplies, operational expenses, and the maintenance of branch offices
- 23 shall not exceed an expenditure maximum equal to 12 percent of the
- 24 estimated income for that year from contributions and interest and
- 25 dividend income on investments less investment expenses. The audited

1 accounts and the budget for the ensuing fiscal year shall be approved by

- 2 the Board and submitted to the President and the Congress of the
- 3 Federated States of Micronesia. Should the estimated costs of
- 4 administration exceed the expenditure maximum, legislative approval of
- 5 the budgeted administration expenses is required.
- 6 CHAPTER 2.

7 SOCIAL SECURITY BOARD AND ADMINISTRATION

8 Section 201. Creation; Composition; Terms; Organization and

9 procedure; Compensation. There is hereby created a Federated States of

10 Micronesia Social Security Board of five members nominated by the

11 President and confirmed by the Congress of the Federated States of

12 Micronesia to operate the Social Security Program authorized by this

13 act. Nominations to the Board shall take into account the need to have

14 adequate geographical representation and to have representatives from

15 public and private sector employers and employees. Members of the Board

16 shall serve 3-year terms, and the Board shall provide for its own

17 organization and procedure. Any vacancies on the Board shall be filled

18 for the unexpired term only. Where a vacancy is for one year or less,

19 it shall be filled by appointment by the President, otherwise vacancies

20 shall be filled by nomination by the President and confirmation by the

21 Congress. The Social Security Administrator shall be an ex-officio

22 member of the Board. Members of the Board who are not Government

23 employees shall be paid at the rate of \$30 per day and necessary travel

24 expenses when actually attending meetings of the Board. If a member of

- 202. Powers and duties generally. The Board shall have the powers 5
- and privileges of a corporation; shall have an official seal; and shall
- in the name of "Federated States of Micronesia Social Security
- Administration" transact all business, enter into contracts, invest all
- funds or retain a firm to invest or reinvest funds under the Board's
- supervision; and, under its rules, regulations, and conditions, transfer 10
- or assign such funds as herein authorized, purchase annuities, and hold 11
- in trust for the purposes for which received, all cash, securities, and 12
- other properties of the system. In the name "Federated States of
- Micronesia Social Security Administration" it may sue and be sued. The
- responsibility for the proper operation of this act shall be vested in
- the Board. The Board shall appoint a Social Security Administrator who 16
- shall have responsibility for the general administration of the Social
- Security System, and who shall have power to employ and to delegate 18
- duties to such employees of the Social Security Administration as deemed 19
- feasible and desirable to carry out the provisions of this act. 20
- Section 203. Promulgation of regulations; Hearings; Employees; ·21
- The Board may adopt, amend, or rescind regulations for 221
- the administration of this act subject to the approval of the President. 23
- It may hold hearings or make decisions upon hearings delegated to others 24
- for the purpose of determining any question involving any right, 25

1 benefit, or obligation of any person subject to this act. It may fix the compensation of such employees it deems necessary within the limits of available administrative funds budgeted for its operation, and it may contract for special actuarial and other counseling on a fee basis. shall bond itself and its employees in such amounts as it shall fix. It shall receive audited accounts of the Social Security System within 90 days of the end of the fiscal year of the system and transmit these accounts to the President and the Congress of the Federated States of Micronesia. The annual accounts and report shall be made available to the public. It shall submit to the President and the Congress for each fiscal year a report on its operations and the condition of its funds, 11 and subject to section 207, in such report shall make recommendations 12 for amendments to this act as it deems desirable. Section 204. Maintenance of records; Disclosure of records. 14 Administrator shall receive and maintain files and records of all 15 employers and all employees subject to this act. Such records shall not 16 be disclosed to any person except as may be required in the 17 administration of this act, or in connection with a hearing conducted in . 18 accordance with the provisions of this act. 19 Section 205. Appointment of branch managers. The Administrator 20 shall have the authority to employ branch managers and delegate such 21

power to such branch managers as may by regulation be prescribed.

Section 206. Audit of records; Power to subpoena; Administration

of oaths. The Board and its authorized representatives shall have the

power to audit employer records, issue subpoenas and administer oaths

1 appropriate to the administration of this act. Section 207. Actuaries and actuarial valuations. The Board shall 2 employ or contract with actuaries or actuarial firms for the purpose of making actuarial valuations of the Federated States of Micronesia Social Security System not less frequently than each 3 years after the date of commencement of the system. Such reports made to the Board shall be submitted with appropriate recommendations for changes in the system and amendments to this act to the President and to the Congress of the Federated States of Micronesia. An actuarial report prepared by a qualified actuary which analyzes the implications on the system of any 10 proposed amendment which has financial implications must accompany the 11 proposed amendment. In particular, proposals to amend section 103, 12 sections 301 to 307 inclusive, section 401 and 402, or chapter 5 must be 13 accompanied by an actuarial report. 14 Section 208. Review of Board determinations. Any person aggrieved 15 by a final order of the Board may obtain a review of the order in the

16 . 17 Trial Division of the Supreme Court of the Federated States of Micronesia by filing in Court, within 60 days after the entry of the 18 order, a written petition praying that the order be modified or set 19 20 aside in whole or in part. A copy of the petition shall be served on 21 the Board, by service on its secretary or other designated agent, and 22 thereupon the Board shall certify and file in Court a copy of the record 23 upon which the order was entered. The findings of the Board as to the facts, if supported by competent, material, and substantial evidence, 24 . 25 shall be conclusive. If either party applies to the Court for leave to

2 the Court that there were reasonable grounds for failure to adduce the

representatives, and that such evidence is competent, material, and

substantial, the Court may order the additional evidence to be taken by

7 such conditions as the Court considers proper. The Board may modify its

findings and order after receipt of further evidence together with any

modified or new findings or order. The judgment of the Court upon the

10 record shall be final, subject to review by the Appellate Division of

11 the Supreme Court upon petition of any aggrieved party, including the

12 Board, within 60 days from judgment.

CHAPTER 3.

15 Section 301. Scope of coverage.

(1) All employees, wherever employed by a Federated States of Micronesia employer, shall be covered unless both the employer and the

18 employee are currently subject to any other recognized Social Security

19 System. For the purposes of this act, any elected official in any

20 Government unit or body in the Federated States of Micronesia is deemed

21 to be an employee employed by a Federated States of Micronesia employer.

22 The governmental unit or body to which such person is elected is subject

23 to the provisions in this act relating to the duty and obligations of a

24 Federated States of Micronesia employer.

(2) Every person who:

(a) Is a fully insured individual, as defined in this

2 act;

(b) Has attained age 60 years; and

- 4 (c) Has filed application for old age insurance shall be
- 5 entitled to an old age insurance benefit for each month, beginning with

- 9 Section 302. Surviving spouse's benefits. The surviving spouse of
- 10 an individual who died fully insured, if such spouse has filed
- 11 application, shall be entitled to a survivor insurance benefit for each
- 12 month beginning with the month of death of the fully insured spouse and
- 13 ending with the month preceding the month in which the surviving spouse
- 14 dies or remarries; PROVIDED that such benefit shall be subject to the
- 15 earnings test as defined in this act.
- Section 303. Dependent's benefits; Disability benefits.
- 17 (1) Every surviving child who is dependent upon an individual
- 18 entitled to old age benefits or who was dependent upon an individual who
- 19 died fully insured or currently insured, shall be entitled, upon filing
- 20 application, to a child's insurance benefit for each month beginning
- 21 with the month of death of such individual and ending with the month
- 22 preceding whichever of the following first occurs:
- 23 (a) Attainment of age 18 years, except that benefits are
- 24 payable until the month before the attainment of age 22 so long as the
- 25 beneficiary is a bona fide student, and except that benefits

1 are payable during the disability of a child who was disabled before the

- 2 attainment of age 22;
 - (b) Marriage; or
 - (c) Adoption.
- 5 (2) A child shall be deemed dependent upon his parent or
- 6 adopting parent unless such individual was not living in the same
- 7 household with or contributing to the support of such child. Child's
- 8 insurance benefits shall be paid to the individual upon whom the child
- 9 is currently dependent, except such benefit shall be subject to the
- 10 earnings test as defined in this act.
- 11 (3) Every individual who is a fully and currently insured
- 12 individual and is disabled and has been disabled for at least 3 full
- 13 calendar months, upon filing an application for disability insurance
- 14 benefits, shall be entitled to a disability insurance benefit for each
- 15 month beginning with the first month of the waiting period and ending
- 6 with the month preceding the month in which he dies or recovers from his
- 17 disability, subject to the earnings test as defined in this act.
- 18 Section 304. Amount of retirement and disability insurance
- 19 benefits.
- 20 (1) An insured eligible individual shall be paid a monthly
- 21 old age benefit for life, except for any month of disqualification as
- 22 provided by this act, in an amount calculated upon an annual basis of
- 23 12.6 percent of the first \$10,000 of cumulative covered earnings, plus
- 24. 2.1 percent of cumulative covered earnings in excess of \$10,000 but not.
- 25 in excess of the next \$30,000, plus 1.05 percent of

1 cumulative covered earnings in excess of \$40,000. Earnings for

- 2 employment after commencement of payments for old age or disability
- 3 insurance benefits shall be included in benefit calculations upon
- 4 subsequent application for benefits, but such earnings shall be
- 5 applicable for benefits for months after the calendar year in which such
- 6 earnings occurred. For the purpose of this section cumulative covered
- 7 earnings includes earnings on which contributions have been paid by the
- 8 individual to the Trust Territory Social Security System.
- 9 (2) An insured, eligible individual shall be paid a minimum
- 10 monthly benefit of \$33.60 if the benefit amount calculated in accordance
- 11 with subsection (1) of this section is less than \$33.60 monthly.
- 12 (3) An individual who is both fully and currently insured and
- 13 who has been under a disability for 3 full calendar months shall be paid
- 14 a monthly benefit for life or until recovery from the disability, except
- 15 for any month of disqualification as provided by this act, in an amount
- 16 calculated in accordance with the preceding subsections of this section.
- 17 Further, the amount of the benefit as so determined shall, if the
- 18 individual is receiving a periodic workmen's compensation benefit, be
- 19 reduced each month by the excess of the sum of the workmen's
- 20 compensation benefit for that month and the benefit payable under this
- 21 'act over 80 percent of one-twelfth of the highest annual covered wages
- 22 in the period consisting of the year in which the disability occurred
- 23 and the preceding five years. If a workmen's compensation benefit was
- 24 payable in periodic benefits but was commuted to a lump sum, for
- 25 purposes of this subsection it will be considered that the periodic

1 benefit originally available was paid in each month that it would have

- 2 been paid if the commutation had not occurred.
- 3 Section 305. Reemployment after retirement. In the event an
- 4 individual who is receiving retirement insurance benefits returns to
- 5 covered employment, the benefit shall be recomputed at the end of the
- 6 calendar year and paid as provided in this act beginning with the year
- 7 after the calendar year the earnings were made.
- 8 Section 306. Amount of survivor insurance benefits.
- 9 (1) The surviving spouse of a fully insured worker eligible
- 10. in accordance with section 303 shall be paid a monthly benefit or
- 11 disability in an amount equal to 60 percent of the retirement or
- 12 disability insurance benefit calculated for the deceased spouse at the
- 13 date of death.
- 14 (2) Each eligible child of an insured worker shall be
- 15 entitled to a monthly benefit of 15 percent of the retirement insurance
- 16 benefit calculated for the deceased parent at the date of death.
- 17 (3) If the spouse of the deceased insured worker is eligible
- 18 for retirement benefit based on his or her own employment coverage, the
- 19 survivor insurance benefit shall be reduced by the amount of such
- 20 retirement benefit.
- 21 (4) In no event shall the total survivor benefit paid to the
- 22 spouse and children exceed the retirement benefit calculated for the
- 23 decedent as of the date of death, nor shall it be less than \$33.60 a
- 24 month computed prior to the application of subsection (3) of this
- 25 section.

Section 307. Lump sum benefits.

- 2 (1) When a worker dies and the benefits paid, including
- 3 survivor benefit, have been less than 4 percent of his cumulative
- 4 covered earnings, the survivors, heirs, or the estate of such individual
- 5 shall be paid a lump sum benefit, after all rights to survivor benefits
- 6 have terminated, in an amount equal to 4 percent of the decedent's
- 7 cumulative covered earnings, reduced by the amount of any benefits paid
- 8 to the insured worker and his eligible dependents. For the purpose of
- 9 this section, cumulative covered earnings includes earnings on which
- 10 contributions have been paid by the individual to the Trust Territory
- 11 Social Security System.
- 12 (2) In the absence of a will, survivors shall be paid in the
- 13 following order:
- 14 (a) Spouse, if living, otherwise children in equal
- 15 shares or guardian, if such children are minors;
- 16 (b) Parents in equal shares; or
- 17 (c) Duly appointed legal representatives of the deceased
- 18 or, if none, person or persons determined to be entitled thereto under
- 19 the laws and customs of the last domicile of the deceased person.
- 20 Section 308. Adjustments to correct for overpayments and
- 21 underpayments.
- 22 (1) Whenever an error has been made with respect to insurance
- 23 payments to an individual, proper adjustment shall be made, under
- 24 regulations promulgated by the Board by increasing or decreasing
- 25 subsequent payments to which such individual is entitled. If such

1 individual dies before such adjustment has been completed, adjustment

- 2 shall be made by increasing or decreasing subsequently paid survivor
- 3 benefit payments payable with respect to the wages which were the basis
- 4 of benefits of such deceased individual.
- 5 (2) No adjustment shall be made when adjustment or recovery
- 6 would be against equity and good conscience.
- 7 Section 309. Payment of benefits to foreign citizens outside
- 8 Federated States of Micronesia.
- 9 (1) Notwithstanding any other provision of this chapter, no
- 10 monthly benefits shall be paid under this chapter to any individual who
- 11 is not a citizen or national of the Federated States of Micronesia for
- 12 any month which is:
- 13 (a) After the sixth consecutive calendar month during
- 14 all of which the administrator finds, on the basis of information
- 15 furnished to him by the Attorney General or information which otherwise
- 16 comes to his attention, that such individual is outside the Republic of
- 17 the Marshall Islands, the Federated States of Micronesia, and the
- 18 Republic of Palau; and
- 19 (b) Prior to the first month thereafter for all of which
- 20 such individual has been in the Federated States of Micronesia. For
- 21 purposes of this paragraph (1), after an individual has been outside the
- 22 Federated States of Micronesia for any period of 30 consecutive days he
- 23 shall be treated as remaining outside the Federated States of Micronesia
- 24 until he has been in the Federated States of Micronesia for a period of
- 25 30 consecutive days.

1	(2) Subsection (1) of this section shall not apply to any
2	individual who is a citizen of a foreign country which the Administrator
3	finds has in effect a social insurance or pension system which is of
4	general application in such country and under which:
5	(a) Periodic benefits, or the actuarial equivalent
6	thereof, are paid on account of old age, retirement, or death, and
7	(b) Individuals who are citizens of the Federated States
8	of Micronesia but not citizens of such foreign country and who qualify
9	for such benefits are permitted to receive such benefits or the
10	actuarial equivalent thereof while outside such foreign country without
11	regard to the duration of the absence.
12	CHAPTER 4.
13	CONTRIBUTIONS
14	Section 401. Employee contributions.
15	(1) There is hereby imposed on every employee a tax equal to
16	the following percentages of wages received by him with respect to
17	employment subject to this act:
18	(a) With respect to wages paid from the effective date
19	of this act through June 30, 1985, the rate shall be 2 percent;
20	(b) With respect to wages paid from July 1, 1985,
21	through June 30, 1990, the rate shall be 3 percent;
22	(c) With respect to wages paid from July 1, 1990, through
23	June 30, 1995, the rate shall be 4 percent;
24	(d) With respect to wages paid from July 1, 1995, through
25	June 30, 2000, the rate shall be 5 percent;
