CONGRESSIONAL BILL NO. 2-98, C.D.1,

**AN ACT**

To further amend Public Law No. 1-118, as amended by Public Laws No. 1-125 and No. 1-148, by appropriating the sum of \$192,200 from the General Fund of the Federated States of Micronesia as supplementals for the operations of the National executive branch, the National judicial branch, the public auditor, and other programs of the National Government of the Federated States of Micronesia for fiscal year 1981, and for other purposes.

**BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:**

1       Section 1. Section 1 of Public Law No. 1-118, as amended by Public  
2 Laws Nos. 1-125 and 1-148, is hereby further amended to read as follows:

3 "Section 1. The sum of \$2,506,900, or so much thereof as may  
4 be necessary, is hereby appropriated from the General Fund of  
5 the Federated States of Micronesia for the executive branch,  
6 national judiciary, Public Auditor, and other programs of the  
7 National Government of the Federated States of Micronesia for  
8 Fiscal Year 1981. The sum appropriated by this act shall be  
9 apportioned as follows:
