

A BILL FOR AN ACT

To appropriate the sum of \$1,298,300 from the General Fund of the Federated States of Micronesia for the purpose of defraying the operating and contingent expenses of the Congress of the Federated States of Micronesia for fiscal year 1982, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Operating expenses of the Office of the Speaker and  
2 Members. The sum of \$604,000, or so much thereof as may be necessary,  
3 is hereby appropriated from the General Fund of the Federated States  
4 of Micronesia for the fiscal year ending September 30, 1982, for  
5 the purpose of defraying the operating and contingent expenses  
6 of the Office of the Speaker and the Members of the Congress of the  
7 Federated States of Micronesia. The sum appropriated by this  
8 section shall be apportioned as follows:

- 9           (1) Members' salaries . . . . . \$213,000
- 10          (2) Members' life insurance and other benefits . . . . . 11,000
- 11          (3) Representation allowance . . . . . 7,500
- 12          (4) Members' office rental . . . . . 28,800
- 13          (5) Members' travel . . . . . 111,700
- 14          (6) Standing committees . . . . . 162,000
- 15          (7) Members' official expense allowance. . . . . 70,000

16       Section 2. Operating expenses of staff offices of the Congress.  
17 The sum of \$554,000, or so much thereof as may be necessary, is  
18 hereby appropriated from the General Fund of the Federated States  
19 of Micronesia for the fiscal year ending September 30, 1982, for  
20 the purpose of defraying the operating and contingent expenses  
21 of staff offices of the Congress. The sum appropriated by this  
22 section shall be apportioned as follows:

- 23           (1) Staff salaries . . . . . \$412,000
- 24          (2) Staff personnel and health benefits. . . . . 29,000
- 25          (3) Overtime . . . . . 14,000

- 1           (4) Staff housing allowance . . . . . \$39,000
- 2           (5) Staff travel. . . . . 30,000
- 3           (6) Recruitment, home leave,
- 4 and repatriation . . . . . 5,000
- 5           (7) Contractual services . . . . . 10,000
- 6           (8) Staff training. . . . . 15,000

7           Section 3. Miscellaneous expenses of the Congress. The sum of  
 8 \$140,300, or so much thereof as may be necessary, is hereby  
 9 appropriated from the General Fund of the Federated States of  
 10 Micronesia for the fiscal year ending September 30, 1982, for the  
 11 purpose of defraying miscellaneous expenses of the Congress  
 12 of the Federated States of Micronesia. The sum appropriated by this  
 13 section shall be apportioned as follows:

- 14           (1) Equipment and furniture . . . . . \$15,300
- 15           (2) Rent and communications . . . . . 21,500
- 16           (3) Utilities . . . . . 5,400
- 17           (4) Printing and reproduction . . . . . 21,500
- 18           (5) Materials and supplies . . . . . 20,000
- 19           (6) Freight . . . . . 3,500
- 20           (7) Repairs and maintenance . . . . . 21,500
- 21           (8) Books and library materials . . . . . 20,000
- 22           (9) Members' and staff health insurance . . . . . 8,100
- 23           (10) POL . . . . . 3,500

24           Section 4. Allotment and responsibility of funds appropriated.

25 The funds appropriated by this act shall be allotted to the Speaker

1 of the Congress of the Federated States of Micronesia or his  
 2 designees, and those funds shall be administered and managed in  
 3 accordance with applicable law, including the Financial Management  
 4 Act of 1979. The Speaker of the Congress of the Federated States of  
 5 Micronesia shall have the authority to reallocate funds appropriated by  
 6 one subsection within a section to another subsection within the  
 7 same section; PROVIDED, HOWEVER, that not more than 10 percent of  
 8 the funds appropriated by a section of this act shall be reallocated  
 9 to another section of this act; PROVIDED FURTHER, HOWEVER, that no  
 10 funds shall be reallocated to recruit unbudgeted personnel. The  
 11 authority to obligate funds appropriated by this act shall lapse  
 12 as of September 30, 1982.

13 Section 5. Effective date. This act shall become law upon  
 14 approval by the President of the Federated States of Micronesia  
 15 or upon its becoming law without such approval.
