A BILL FOR AN ACT

To appropriate the sum of \$25,900 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of funding the operations of the State delegation offices of the Congress of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$25,900, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 1982, for the purpose of funding the operations of
5 the State delegation offices of the Congress of the Federated States
6 of Micronesia. The sum appropriated shall be apportioned in the
7 following manner:

8 Kosrae Delegation Office:

- 9 (1) Printing and reproduction \$ 600
- 10 (2) Office supplies 500
- 11 (3) Vehicle or rental boat 600

12 Ponape Delegation Office:

- 13 (1) Vehicle or boat rental..... 1,500
- 14 (2) Printing and reproduction..... 600
- 15 (3) Contingency 500
- 16 (4) Office supplies 600
- 17 (5) Purchase of office vehicle 7,000

18 Truk Delegation Office:

- 19 (1) Vehicle or boat rental 2,500
- 20 (2) Printing and reproduction..... 1,000
- 21 (3) Office supplies 500
- 22 (4) Contingency 600
- 23 (5) Purchase of office vehicle..... 7,000

24 Yap Delegation Office:

- 25 (1) Vehicle or boat rental..... 1,000

- 1 (2) Office supplies \$ 500
- 2 (3) Printing and reproduction 600
- 3 (4) Contingency 300

4 Section 2. All funds appropriated by this act shall be
 5 allotted, managed, administered, and accounted for in accordance
 6 with applicable law, including, but not limited to, the Financial
 7 Management Act of 1979. The allottee shall be responsible for
 8 ensuring that these funds, or so much thereof as may be necessary,
 9 are used solely for the purpose specified in this act, and that
 10 no obligations are incurred in excess of the sum appropriated.
 11 The authority of the allottee to obligate funds appropriated by
 12 this act shall lapse as of September 30, 1983.

13 Section 3. This act shall become law upon approval by the
 14 President of the Federated States of Micronesia or upon its
 15 becoming law without such approval.
