A BILL FOR AN ACT

To appropriate the sum of \$571,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1983, for the purpose of funding various public projects in the State of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$571,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September 30,
4 1983, for the purpose of funding various public projects in the State
5 of Yap. The funds will be apportioned as follows:


22 Section 2. All funds appropriated by this act shall be allotted,
23 managed, administered, and accounted for in accordance with applicable
24 law, including, but not limited to, the Financial Management Act of
25 1979. The allottee shall be responsible for ensuring that these funds,

1 or so much thereof as may be necessary, are used solely for the
2 purpose specified in this act, and that no obligations are incurred
3 in excess of the sum appropriated. The authority of the allottee to
4 obligate funds appropriated by this act shall lapse as of September 30,
5 1983.

6 Section 3. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its becoming
8 law without such approval.
