A BILL FOR AN ACT

To amend section 101 of title 3 of the Code of the Federated States of Micronesia to reapportion the Congress in 1984, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 101 of title 3 of the Code of the Federated 2 States of Micronesia is hereby amended to read as follows: "Section 101. Membership and terms of office. The Congress 3 of the Federated States of Micronesia shall be a unicameral 5 National legislature consisting of fourteen Members to be known as Senators as follows: (1) four at-large Members, one from each of the States of Kosrae, Ponape, Truk, and Yap, who are elected on the basis of State equality to serve for a four-year term. 10 (2) ten Members serving for a term of two years and 11 elected on the basis of population as follows: 12
 - (a) one Member elected from Kosrae as a singlemember congressional district;
 - (b) one Member elected from Yap as a singlemember congressional district;
 - (c) three Members elected from Ponape, one of whom representing each single-member congressional district;
 - (d) five Members elected from Truk one of whom representing each single-member congressional district.
 - (3) single-member congressional districts shall be reapportioned at least every 10 years. The first such reapportionment shall be made in 1989 1984 with 15 Members serving for a term of two years and elected on the basis of population as follows:
- (a) one Member elected from Kosrae as a single-25
