A BILL FOR AN ACT

To further amend section 1 of Public Law No. 2-34, as amended by Public Laws Nos. 2-44 and 3-12, which appropriated the sum of \$846,200 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of funding certain public projects in the State of Truk, and for other purposes.

**BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:**

- 1       Section 1. Section 1 of Public Law No. 2-34, as amended by  
2       Public Laws Nos. 2-44 and 3-12, is hereby further amended to read  
3       as follows:

4           "Section 1. The sum of \$846,200, or so much thereof as may  
5       be necessary, is hereby appropriated from the General Fund  
6       of the Federated States of Micronesia for the fiscal year  
7       ending September 30, 1982, for the purpose of funding  
8       certain public projects in the State of Truk. The sum  
9       appropriated by this section shall be apportioned as
