## A BILL FOR AN ACT

To further amend sections 1, 5, and 7 of Public Law No. 3-18, as amended by Public Law No. 3-39, to appropriate supplemental funding for the Office of the Attorney General and the Micronesian Maritime Authority, to authorize an additional employment position for the Micronesian Maritime Authority, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 1 of Public Law No. 3-18, as amended by Public  
2 Law No. 3-39, is hereby further amended to read as follows:

3       "Section 1. Operating expenses of the executive branch. The  
4       sum of \$1,032,100, or so much thereof as may be necessary, is  
5       hereby appropriated from the General Fund of the Federated  
6       States of Micronesia, and the sum of ~~\$4,717,118~~ 4,794,290, or  
7       so much thereof as may be necessary, is hereby appropriated  
8       from the United States Grant Special Fund for the fiscal year  
9       ending September 30, 1984, for the operations of the executive  
10      branch of the National Government of the Federated States of  
11      Micronesia during fiscal year 1984. The sums appropriated  
12      by this section shall be apportioned as follows:

11          General Fund of the Federated States of Micronesia, and the  
12          sum of \$1,200,000, or so much thereof as may be necessary,  
13          is hereby appropriated from the United States Grant Special  
14          Fund for the fiscal year ending September 30, 1984, for the  
15          operations of independent agencies, commissions, authorities,  
16          boards, bureaus, and other organizations of the National  
17          Government of the Federated States of Micronesia during fiscal  
18          year 1984. The sums appropriated by this section shall be  
19          apportioned as follows:

1 and legislative branches, the National judiciary, the Public  
2 Auditor, and to the agencies as provided in subsection (1)  
3 of this section, except that the President may transfer up  
4 to 12 positions between the departments and offices of the  
5 executive branch. This authorization of positions covers  
6 all permanent employees, all contract personnel whose  
7 employment extends for 1 year or more, and all positions  
8 funded from United States federal programs. No funds may  
9 be expended for unbudgeted positions."


10 Section 4. This act shall become law upon approval by the President  
11 of the Federated States of Micronesia or upon its becoming law without  
12 such approval.
