- 12 and guided the task force to a better understanding of the needs of the
- 13 Micronesian people; and
- 14 WHEREAS, through his tireless and dedicated efforts as chairman of
- 15 the Committee on General Provisions of the Micronesian Constitutional
- 16 Convention, Petrus Tun was an inspirational leader of the Constitutional
- 17 Convention; and
- 18 WHEREAS, Petrus Tun chaired the Senate Committee on Judiciary and
- 19 Governmental Operations during both the Seventh Congress of Micronesia
- 20 and the Interim Congress of the Federated States of Micronesia; and
- 21 WHEREAS, Petrus Tun served as a member of the Status Commission
- 22 and as chairman of its Committee on Transition; and
- WHEREAS, Petrus Tun served with distinction and honor as the first
- 24 Vice President of the Federated States of Micronesia; and
- WHEREAS, Petrus Tun nobly and unselfishly volunteered not to run for

l reelection so that the honor of the vice presidency would be bestowed

- 2 upon a Senator from another State; and
- 3 WHEREAS, Petrus Tun will continue to shoulder important respon-
- 4 sibilities in the Federation by serving on the Federated States of
- 5 Micronesia Status Commission and chairing the Plebiscite Commission;

- WHEREAS, it is the sense of the Congress that Petrus Tun is deserving
- 8 of the most sincere gratitude and the highest praise and honor for his
- 9 unwavering loyalty, professionalism, and dedicated service to his people;
- 10 now, therefore,
- 11 BE IT RESOLVED by the Third Congress of the Federated States of
- 12 Micronesia, First Regular Session, 1983, that the Congress hereby commends
- 13 Petrus Tun for his unwavering loyalty, professionalism, and service to
- 14 the Congress of Micronesia, the Micronesian Constitutional Convention,
- 15 the Interim Congress, the National Government of the Federated States of
- 16 Micronesia, and all the people of Micronesia; and
- 17 BE IT FURTHER RESOLVED that the Congress hereby commends Petrus Tun
- 18 for his outstanding and lasting contribution to the cause of Micronesian
- 19 self-government; and

- 22 Micronesia, and the Governor and Speaker of the legislature of each State
