A RESOLUTION

Distributing the goods and services to be made available under the recently concluded agreement between the Micronesian Maritime Authority and the Federation of Japan Tuna Fisheries Co-operative Associations, the National Offshore Tuna Fisheries Association of Japan, the Japan Far Seas Purse Seine Fishing Association, and the Federation of North Pacific District Purse Seine Fisheries Co-operative Associations of Japan.

WHEREAS, the Micronesian Maritime Authority did conclude an

WHEREAS, under the terms of this agreement, goods and services

16 with the value of approximately \$85,000 will be provided to the States

17 of the Federated States of Micronesia; and

WHEREAS, section 415(3) of title 24 of the Code of the Federated

19 States of Micronesia provides that fees from foreign fishing agreements

20 paid in goods and services shall be distributed by resolution of the

21 Congress of the Federated States of Micronesia; and

22 WHEREAS, it is the sense of the Congress of the Federated States

23 of Micronesia that a distribution formula based on 30 percent of the

24 total approximate value being distributed equally and 70 percent being

25 distributed according to population is the most equitable; now, therefore,

1	BE IT RESOLVED by the Third Congress of the Federated States of
2	Micronesia, Second Special Session, 1984, that the goods and services
3	provided under the agreement mentioned above are hereby distributed in
4	monetary value as follows:

9	BE IT FURTHER RESOLVED that certified copies of this resolution
10	be transmitted to the President of the Federated States of Micronesia,
11	the Speaker of the Congress of the Federated States of Micronesia,

13	the Governor of Ponape State, the Speaker of the Ponape State Legislature,
14	the Governor of Yap State, the Speaker of the Yap State Legislature, the
15	Governor of Kosrae State, the Speaker of the Kosrae State Legislature,
16	and the Executive Director of the Micronesian Maritime Authority.
