- 14 of Legislative Counsel; and
- WHEREAS, throughout his tenure with Congress, Michael Berman has distin-
- 16 guished himself through his leadership ability, legal skill, hard work, and
- 17 dedication; and
- 18 WHEREAS, Michael Berman has submitted his resignation from the position
- 19 of Legislative Counsel, effective June 12, 1984; and
- WHEREAS, Congress has most reluctantly accepted Michael Berman's resig-
- 21 nation; now, therefore,
- 22 BE IT RESOLVED by the Third Congress of the Federated States of Micronesia,
- 23 Third Regular Session, 1984, that the Congress hereby expresses its deepest
- 24 gratitude and appreciation to Michael Berman for his many years of outstanding
