A BILL FOR AN ACT

To appropriate the sum of \$914,400 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, for the purpose of funding various development, education, and health related projects and programs in the Federated States of Micronesia to be administered by the National Government's Departments of Resources and Development and Social Services, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$914,400, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Feder-
3 ated States of Micronesia, for the fiscal year ending September 30,
4 1985, for the purpose of funding various development, education, and
5 health related projects and programs in the Federated States of
6 Micronesia to be administered by the National Government's Departments
7 of Resources and Development and Social Services.

8 Section 2. The sum appropriated by section 1 of this act shall
9 be apportioned as follows:

10 (1) Department of Resources and Development

- 11 (a) On-going projects and programs.....\$180,000
- 12 (b) Veterinary services programs..... 10,000
- 13 (c) Artificial insemination program..... 5,000
- 14 (d) COM land grant matching funds
- 15 program..... 15,000
- 16 (e) Regional livestock
- 17 development/goat project..... 20,000
- 18 (f) Seminar for cooperatives, credit
- 19 unions, corporations, exporters, importers, and
- 20 general business outlets to be held in the State
- 21 of Truk..... 20,000

22 (2) Department of Social Services

- 23 (a) Supplies and equipment for Faichuk
- 24 and Satawan superdispensaries..... 160,000
- 25 (b) Medical supplies for the State of



- 2 (c) Medical supplies for the State of
- 3 Truk..... 100,000
- 4 (d) Medical supplies for the State of
- 5 Ponape..... 100,000
- 6 (e) Medical supplies for the State of

- 8 (f) Supplemental assistance to settle
- 9 the States' medical referral accounts..... 200,000
- 10 (g) Matching fund for vocational
- 11 rehabilitation services program..... 4,400.
- 12 Section 3. All funds appropriated by this act shall be allotted,
- 13 managed, administered, and accounted for in accordance with applicable
- 14 law, including, but not limited to, the Financial Management Act of
- 15 1979. The allottee shall be responsible for ensuring that these
- 16 funds, or so much thereof as may be necessary, are used solely for the
- 17 purposes specified in this act, and that no obligations are incurred
- 18 in excess of the sum appropriated. The allottee shall be the
- 19 President of the Federated States of Micronesia. The authority of the
- 20 allottee to obligate funds appropriated by this act shall lapse as of
- 21 September 30, 1985.
