A BILL FOR AN ACT

To amend sections 2 and 7 of Public Law No. 3-18, which appropriated the sum of \$4,374,119 from the General Fund of the Federated States of Micronesia and the sum of \$6,545,974 from the United States Grant Special Fund for the fiscal year ending September 30, 1984, for the operations of the executive branch, legislative branch, National judiciary, Public Auditor, agencies of the National Government, and for special programs, contributions, grants, subsidies, and refunds of the National Government during fiscal year 1984 and which established employment ceilings, in order to increase the operating expenses and the employment ceiling of the legislative branch, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 3-18 is hereby amended
2 to read as follows:

3 "Section 2. Operating expenses of the legislative branch.

4 The sum of ~~\$1,468,633~~ \$1,505,135, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund
6 of the Federated States of Micronesia for the fiscal year
7 ending September 30, 1984, for the operations of the legis-
8 lative branch of the National Government of the Federated
9 States of Micronesia during fiscal year 1984. The sums
10 appropriated by this section shall be apportioned as
11 follows:

1 (2) The number of positions authorized applies
2 individually to each of the departments and offices of the
3 executive and legislative branches, the National judiciary,
4 the Public Auditor, and to the agencies as provided in
5 subsection (1) of this section, except that the President
6 may transfer up to 12 positions between the departments and
7 offices of the executive branch. This authorization of
8 positions covers all permanent employees, all contract
9 personnel whose employment extends for 1 year or more, and
10 all positions funded from United States federal programs.
11 No funds may be expended for unbudgeted positions."

13 Section 3. This act shall become law upon approval by the
14 President of the Federated States of Micronesia or upon its becoming
15 law without such approval.
