## AN ACT

To further amend Public Law No. 3-18, as amended, by amending section 5 to appropriate the sum of \$40,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1984, for the purpose of providing supplemental sums for the Commission on Future Political Status and Transition and the Micronesian Maritime Authority, and for other purposes.

## BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 5 of Public Law No. 3-18, as amended by		
2	Public Laws Nos. 3-39, 3-42, and 3-49, is hereby further amended to		
3	read as follows:		
4	"Section 5. Operating expenses of agencies of the National		
5	Government. The sum of \$1,346,384, or so much thereof as		
6	may be necessary, is hereby appropriated from the General		
7	Fund of the Federated States of Micronesia, and the sum of		
8	\$1,200,000, or so much thereof as may be necessary, is hereby		
9	appropriated from the United States Grant Special Fund for		
10	the fiscal year ending September 30, 1984, for the operations		
11	of independent agencies, commissions, authorities, boards,		
12	bureaus, and other organizations of the National Government		
13	of the Federated States of Micronesia during fiscal year 1984.		
14	The sums appropriated by this section shall be apportioned		
15	as follows:
